



Patron Release Waiver Liability Form

I, the recipient (Patron), understand that the bike I am taking home was checked over by a Pata Bike Mechanic to the best of their abilities and have used the *Pata Bike Tune up Guide* as reference for any maintenance. If any maintenance was done by myself (Patron), I understand that I have used the *Pata Bike Tune up Guide* as reference or the *Bicycle Pre-Ride List Checklist* as a guide for any bike maintenance done. Any harm caused once the bike is taken home is the responsibility of the Patron. The Alliance of Chicanos, Hispanic and Latin Americans (ACHLA) its staff (including volunteers), Board of Directors, and affiliated agencies shall not be held liable for any claims, demands, actions, or causes of action, whatsoever, for any injury caused to me as a result of my involvement in or ACHLA related to Pata de Perro- Community Bike Club or from the bike that I take home. Patron understands that taking a bike home can have some risk associated with it.

1. **Waiver and Release:** I, the Patron, release and forever discharge and hold harmless ACHLA and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the any maintenance on a bike by a Volunteer or instructed by an ACHLA Volunteer. I understand and acknowledge that this Waiver of Liability discharges ACHLA from any liability or claim that I may have against ACHLA with respect to bodily injury, personal injury, illness, death, or property damage that may result from the bike I take home from ACHLA.
2. **Insurance:** I understand that ACHLA does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of ACHLA beyond what may be offered freely by ACHLA in the event of injury or medical expenses incurred by me once I take the bike home.
3. **Photographic Release:** I grant and convey to ACHLA all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by ACHLA in connection with any amount of time at any location that ACHLA is providing a program.

4. **Medical Treatment:** I hereby Release and forever discharge ACHLA from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time at an ACHLA program location.

5. **Assumption of Risk While Fixing a Bike:** I understand that working on a bike may include activities that may be hazardous to me. As a Patron, I hereby expressly assume risk of injury or harm from these activities and ACHLA from all liability.

6. **Assumption of Risk While Riding a Bike:** I acknowledge that participation in biking activities involves inherent risks and dangers that cannot be eliminated, despite taking precautions such as wearing a helmet, lights, and reflective gear. I understand that these risks may result in serious injury, disability, or even death. I voluntarily assume all risks associated with biking, including but not limited to, the risks of falls, collisions with pedestrians, vehicles, or other cyclists, hazardous road conditions, equipment failure, and negligence of others.

7. **Other:** As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Minnesota and that this Release shall be governed by and interpreted in accordance with the laws of the State of Minnesota. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

I hereby agree to hold Alliance of Chicanos, Hispanic and Latin Americans (ACHLA) its board, volunteers, agents, and contractors harmless and I waive any right to make claims or bring lawsuits against any of the afore mentioned parties for any injuries or damages related to any alleged negligence.
